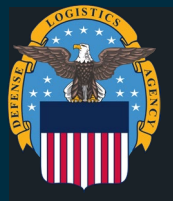

Simplified Steps to a Direct Award Contract



1 SBA Offer Letter

Acquisition official completes intent to award direct award Offer Letter with description of project and identified 8(a) company to SBA Representative (in accordance with 13 CFR 124.502c)



2 SBA Review & Acceptance

SBA reviews Offer Letter, verifies 8(a) eligibility for company identified and sends letter of acceptance to acquisition official



3 Negotiations & Project Scope Planning

Acquisition official informs 8(a) that may enter into project scope planning and negotiations on joint development of project plan (13 CFR 124.503)



4 Contract Award

Once mutually acceptable terms are negotiated, a direct award contract is provided
