SBA Offer Letter

Acquisition official completes intent to award direct award Offer Letter with description of project and identified 8(a) company to SBA Representative (in accordance with 13 CFR 124.502c)



SBA Review & Acceptance

> SBA reviews Offer Letter, verifies 8(a) eligibility for company identified and sends letter of acceptance to acquisition official



Negotiations & Project Scope Planning

Acquisition official informs 8(a) that may enter into project scope planning and negotiations on joint development of project plan (13 CFR 124.503)



Once mutually acceptable terms are negotiated, a direct award contract is provided
